ENTRY FEES & DEADLINES:

- Early registration for **12x14 (Antiques & Collectibles)** **NEW: 10x10 (Arts & Crafts) 10x10 (Commercial)** space is \$95.00
- Registration fee for entries postmarked later than 2 weeks prior to show is \$105.00 per space
- Register for BOTH May and August shows prior to March 16 and take \$20 off the total price. Total cost will be \$170 for both shows.
- To reserve your space(s), fill out the application(s) and release(s) and return with your check or money order to:

DEADLINES:

March 16: Register for both shows for a \$20 discount. Total cost for both shows is \$170

OTHER INFORMATION:

- **Please send a #10 self-addressed stamped envelope with your application.**
- Rules and space assignments will be mailed after applications are received and approved.
- Refunds must be requested 4 weeks prior to show.
- **NEW** dealers **ONLY MUST** send a photograph of items typical of those which will be sold; include name and address on the back of each photo.
- Applications must provide the names of other dealers who will share the space.
- Vendors must have a sales tax permit (resale) number and report sales to the State Board of Equalization. Please send a copy of your current sales tax permit with your application. Dealers must also have their permit on display or in their possession during the Faires. Persons who wish to sell private collections and will sell only 1 or 2 times during the year may request a State Board of Equalization form.
- Vendors must provide their own tables, displays, etc. No electricity is available. Canopies or umbrellas are recommended.
- We reserve the right to refuse entry to any dealer who does not comply with the rules of the faire. This includes items not acceptable for sale.
